## INVITATION

## **Final Reminder**

Ranchi, dated 8<sup>th</sup> October, 2014

Dear All: Ex-Students, Members of Netarhat Vidyalaya family- Past and Present Sub: Diamond Jubilee (DJ) celebrations (13-15 Nov'14) of Netarhat Vidyalaya.

## **SYNOPSIS**

- 1. Registration & Delegates' Fees: Rs. 7500/-per head (Break-up given below)
- 2. Transport: Ranchi-Netarhat-Ranchi & local at Netarhat: Rs.700/-per head
- 3. Meals: 4 Nights, 5 Days: Rs.350/-per meals +Rs.250/- per Breakfast +Rs.250/-Tea, snacks per head
- 4. Misc. Exp.: Rs. 800/-per head (Generators, Mattresses etc)

NOTE: 1. Last date for Response - 20 October, 2014

2. For transit stay at Ranchi, on way to and way back from Netarhat, the delegates may contact Ranchi NOBA President, Shri Girish Nath Singh (Mob: 94311-04010) and /or Gen.secy, Dr. Amar Verma (Mob: 9835527473)

This is in continuation of my earlier letters dated 4.6.2014 and 18.7.2014 to you in the above connection as uploaded on the NVS website. It is reiterated that there isn't any govt budgetary support for meeting expenses on Delegates' stay, meals etc during the DJ celebrations and hence this letter.



- 2. Responses so far for registration of Delegates for participation in the 3 day event have been somewhat muted and lukewarm; only 14 NOBs have registered themselves by remitting, online, the registration amount of Rs. 1000/- each. However, as per information available, informally though, some 250-300 persons are likely to join the DJ celeb events and are purportedly awaiting detailed programme as also the estimated expenditure (as worked out) on stay, transport, meals etc in this regard. This has, however, resulted in problems at this end for undertaking any firm exercise till such time as the approximate (if not actual) number of Delegates reaching Netarhat (for whom school admin is to make required arrangements) is known.
- 3. The time now for making arrangements for Delegates and those for DJ events, you may kindly appreciate, is hardly adequate for ensuring that things, in totality, are firmed up and are in place. It's, in fact, a question of deciding at your end right away in terms of either 'yes' or 'no', for only then all arrangements can be fixed at this end.
- 4. I may, however, like to share with you that arrangement for stay of Delegates has been worked out nicely with lesser burden of expenses. The state govt's 'Jungle Warfare Training Centre' at Netarhat a permanent police establishment for many years now has agreed to provide rent –free stay facility for Delegates. Some newly built pucca buildings inside the well-fenced and protected campus shall be made available that may accommodate 350- 400 people; in fact, Delegates would be the first users of these newly built structures. This would, additionally, take care of the security concerns of the Delegates during their stay at Netarhat. The said 'Centre' is about 2 km on the north-west side from our school and buses would be available to commute during DJ events.
- However, other fixtures, like, mattresses, pillows, bed-sheets, blankets etc will have to be organized on rent to make the stay of Delegates comfortable and hassle-free to the maximum extent possible. This has been worked out in some detail and a statement relating thereto is enclosed here as Annexure-1.
- 5. The 3 day DJ events and detailed programme in this regard, as finalised, find mention in a separate sheet enclosed here as Annexure- 2.
- 6. On perusal of Annexure- 2 it may be evident that per Delegate expenses on stay, transport, meals etc at Netarhat for 4 nights 5 days (from 12 Nov'14 evening 16 Nov'14 forenoon) are approx Rs. 7,500/-. It would mean that a Delegate desirous of availing of the said facilities may have to register and remit quickly a sum of Rs. 7,500/- to 'Netarhat Vidyalaya Vikas Kosh' SB A/c no. 11873383941 IFC Code: SBIN0002985; those, however, having registered earlier with remittances of



Rs. 1000/- each, may now need to remit Rs. 6,500/- only. Further, such remittances may now need to be ensured by 20 October, 2014 positively to confirm participation and availing of facilities for stay etc as organised by us. Prompt remittances of 'Delegates' Fees', as above, by Oct 20, 2014 deadline is very critical and absolutely essential, since the Agency to be tagged for fixing issues of stay, meals etc may swing into action only on receipt of payment by way of advance.

I may wish to make it very clear that Ashrams and Acharya Niwas may not be in a position to accommodate the Delegates as they are already filled beyond their capacity. 6 ashrams of 1<sup>st</sup> and 3<sup>rd</sup> set, now undergoing major repairs, stand vacated and the boys and teachers earlier residing there are accommodated in other ashrams and Acharya Niwas.

It also seems relevant to mention that those not remitting the Delegates' Fees by  $20^{th}$  Oct' 14, may be construed to be on their own for stay, meals etc during DJ events.

7. Finally, I may like to assure one and all that your alma mater and the school family are eagerly awaiting to welcome you all in our midst to make this occasion historic and truly memorable one. Very prompt response, therefore, from your end is solicited.
