Sealed tenders are invited for Netarhat Residential School, Netarhat from Primary Manufacturers Or Authorized dealers having relevant experience under two bid system i.e. Technical Bid & Financial Bid for Supply, Installation, Testing and Commissioning Of 30 KVA Silent Power Genset with Standard Control Panel for Netarhat Residential School premises at Netarhat-835218, District-Latehar, Iharkhand.

Terms and Conditions

1. Eligibility Criteria (all points are mandatory)

- **a.** The Bidder should be a leading name in the field of respective items.
- **b.** Bidder should be an Original Equipment Manufacturer (OEM)/Authorized Dealers.
- c. The bidders must submit self-attested copies of last three year income tax return i.e-P.Y-2013-14,2014-15 and 2015-16 in the name of the firm/proprietor/partner.
- **d.** The bidder shall provide the Registration number of the firm along with the TIN/CST/GST No. and the PAN Number allotted by the concernedauthorities.
- **e.** The bidder must have experience of supplying similar orders of items/equipments as mentioned in list. The documentary evidence of this regard must beattached.
- **f.** One OEM can give only one quote either directly or through an authorized distributor/dealer /service provider.
- **g.** The bidder must not be blacklisted either by Netarhat Residential School, Netarhator any other University/institution/Government department. An affidavit to thiseffect e submitted.
- **h.** Entirework must be implemented within stipulated time from the date of issue of Purchase order. Delay in delivery willhave penalty of 0.5 % of order value per week to total of 5% of order value.
- i. <u>Netarhat Residential School reserves the right to accept or reject any or all quotations</u> without giving any reason. the decision of the Tender Committee Shall be final and <u>Unchallengeable in any Court Of Law.</u>
- **j.** Netarhat Residential School, Netarhat reserves the right to cancel or giving the order to some other party who have contested in this tender if it is not deployed even after the date mentioned in the purchase order. Delay due to school would not beconsidered.
- k. The bidder Should enclosed Of Catalog In Technical Bid Specified as per Tender.
- **l.** The Bidder Shall mention Validity Of Offer, Terms of Payment, Guarantee/Warranty period and schedule Of delivery.
- **m.** The Contractor Shall not assign Or Sub- let his Contract or any Substantial part thereof to any Other agency.
- **n.** The Purchase Committee reserves the right to accept tender not necessarily the Lowest, reject any tender without assigning any reasons and accept tender for all or anyone or more of the articles for which tenderer has been given Or distribute items Of Stores to more than One Firm.

2. Cost of tender

Cost of tender form is Rs. 2,000.00 which is to be submitted in the form ofbank draft from any nationalized bank in favour of the Principal,Netarhat Residential School payable at Netarhatmust be enclosed with the tender form. Cost of tender form is Non-refundable.

3. Earnest Money Deposit:

The interested firm may put the complete document in all respects along with EarnestMoney Deposit (EMD) as a demand draft from any nationalised bank of India drawn infavour of principal, Netarhat Residential School payable at Netarhat. The details of payableEMD is mentioned below:

The bidder should deposit Rs.5000 as EMD.

- i. The EMD should be enclosed in a separate envelop.
- ii. The EMD will be returned to the successful bidder on providing the security deposit.
- iii. EMD will not be waived under any circumstances.
- iv. Non submission of EMD will lead to rejection of tender at the opening stage itself.

4.Security Deposit

- **a)** Within 15 days of award of work order/purchase order, the vendor shall furnish a security deposit amounting to 10% of Purchase Order value in the form of Fixed Deposit,/NSC/ Bank Guarantee/Bond (from scheduled bank only) favouring the Principal,Netarhat Residential School,Netarhat.
- **b)** No Other Kind Of Securities money will entertained. if Successful bidder Shall not Submitting Security money within prescribed time Or form the Tender Committee reserves the right to reject to those Tender Supply Order at any time.
- c) The security deposit should be kept for entire warranty period i.e. One Year
- **d)** The security deposit will be forfeited in the case of non-execution of the order and non compliance of the term and conditions mentioned in the tender document.

5. Submission of Tender

- a) Separate envelopes for tender fees, EMD along with all document and annexure except price bid shall be submitted with Technical Bid and Financial Bid shall only contain the price bid duly sealed envelopes (Envelop I, II and III) should be placed in onebig cover and sealed with the superscription Tenderfor Supply, Installation, Testing and Commissioning Of 30 KVA Silent Power Gensetwith Standard Control Panel For Netarhat Residential School campus situated at Netarhat, District- Latehar.
- **b)** All Bids must reach and be received by the purchaser on or before the prescribed date line during the Office hours i.e. 18.05.2017 at 11.30 a.m.
- **c)** Late bids will not be entertained and returned Unopened to the bidder.
- **d)** The school reserves the right to ignore any tender which fails to comply with the aboveinstructions.
- **e)** The tender not submitted in the prescribed format or incomplete in detail isliable for rejection. The School will not be responsible for the non-receiptof quotations within the specified date and time due to any reasonincluding holidays or delay.

A. Envelope I (Tender fee)

The Tender fee should be enclosed in a separate envelop marked for the same andnoting to be made in the original covering letter.

B. Envelope II (Technical Bid)

The technical bid/offer should be complete in all respects and contain allinformation asked for except prices. The Technical offer should include allcomponents asked for in Annexure I-V. The suggested format forsubmission of technical offer is as follows:

- i. Covering Letter as per Annexure I with Company Seal.
- ii. The Company profile as per Annexure II with Company Seal.
- iii. Details of 3 major projects as per Annexure III with Company Seal.
- iv. Warranty Compliance statement as per Annexure IV with Company Seal.
- v. Technical Specification as per Annexure- V with Company Seal.
- vi. Undertaking (on stamp paper of Rs. 10.00) that the successful bidder agrees to submit a security deposit amounting 10% of Purchase Order Value in form of NSC/ Bank Guaranty/FD/Bond in favour of the Principal Netarhat Residential School, Netarhat.
- vii. The tender form should be completed in all aspect as mentioned in last of the tender document.

C. Envelope III (Financial Offer)

The Financial Offer (C.O.) should give all relevant price information. The Bid Form must be filled in completely, without any errors, or alterations. The Financial offer must not contradict the technical offer in any way.

6. Opening of Tender:

- a. The tender will be opened in the office of The Principal, Netarhat Residential School, Netarhaton 18th May, 2017 at3.30 P.M.
- b. Financial Bids of only those firms shall be opened which qualify in technicalbids and would be opened on 19th May, 2017 at 3.30 P.M
- **c.** The bidders have to be present or send their authorized a representative to be present in the opening of the tender at the time and date specified in the Schedule.

7. Offer validity Period

The offer must be valid for a period of **Six Month** from the closing date of thetender. Any offer falling short of the validity period is liable for rejection.

8. Costs and Payment Terms

- **a.** The offer should include the cost of all type of Gen-Set and all required accessories inclusive of all taxes and statutory levies including labor/installation charges if any.
- **b.** Vague terms like "packing, forwarding, transportation etc. extra" withoutmentioning the specific amount will not be accepted. Such offers shall betreated as incomplete and rejected.
- **c.** Bidders shall indicate their rates in clear/visible figures as well as in wordsand shall not alter/overwrite/make cutting in the quotation. In case of amismatch, the rates written in words will prevail.
- **d.** Discount, if any, should be indicated prominently.
- e. Payment will be made after the successful delivery, installation and commissioning of their scope of work mentioned in respective work/purchase orders.
- f. No advance payment will be made. Payment will be made Subject to the Clearance of the Store Section.

9. Scope Of Work:

Scope of work shall include Supply ,Testing and Commissioning Of 30 KVA , Silent Power Generator Set with Central Control Board approved Acoustic Enclosure comprising of Diesel engine with standard accessories coupled to alternator mounted on Channel Iron Base frame with Vibration free Pads, Complete with fuel tank having Sufficient Capacity for Minimum 8 hours of Operation with Auto Main Failure (AMF).

10. No Commitment to Accept Lowest rate in the Tenderprocedure.

- i. The School shall be under no obligation to accept thelowest or any other offer received in response to this tender notice and shall beentitled to reject any or all offers including those received late or incomplete without assigning any reason whatsoever.
- ii. The school reserves the right to make any changes in the terms and conditions of the work.
- iii. The School will not be obliged to meet and have discussions with any vendor, and or to listen to any representations.

11. Order Cancellation

- i. The School also reserves the right to cancel the orderin the event of one or more of the following circumstances:
- ii. Delay in work beyond the stipulated time mentioned in the work order from the date of issueof the work order.
- iii. Breach by the tenders of any of the terms and conditions of the tender.
- iv. Any action by the vendor, which is in breach of law or accepted practices in the commercial transactions.
- v. If the Firm/Vendor goes into liquidation voluntarily or otherwise.

12. Completeness of the Contract

The contract will be deemed as incomplete until the system becomes fullyoperational. Until then the installation will be termed as incomplete and thewarranty period will not commence. The warranty period will commence only onacceptance (based on acceptance test) of the installation.

13. Pre-installation requisites:

Pre-installation requisites (electrical/floor/space etc.), should be done from the vendor on their own cost at site before submission of tender.

14. Installation and Commissioning:

Free of cost at Netarhat Residential School, Netarhat.

15. Tender updates:

16. Signing of Tender:

Tenderer shall extend Comprehensive Annual maintenance Contract For the Whole System for a period of Three Years after the Completion of Performance warranty Period. Supplier has to Provide Service Support within 8 Hours through the authorized Servicing Party of the Generator. rate of CAMC shall be Prescribed Format as per Given. (mandatory).
