1. Rates quoted shall be inclusive of all taxes , levies, LBT, transport, installation, commissioning etc.
2. Netarhat Vidyalaya reserves right to accept or reject any tender without assigning any reason thereof.
3. Time limit for supply and installation of Aquaguard water cooler cum purifier is 10 days from the date of placing Work Order.
4. The Agency/Firm must be registered in GST . The vendor should attach the GST registration certificate and copy of returns.
5. The agency has to give a warranty of three years for repair and maintenance. The firm/vendor will have to submit the affidavit on stamp paper of Rs. 100/-
6. **Payment Terms :**
  - a) Within 20 days from successful supply and installation of the Aquaguard water cooler cum purifier.
  - b) TDS deduction will be done as per the income tax act 1961 at the time of payment.
7. The Netarhat Vidyalaya reserves the right to cancel this quote at any time without assigning a reason.
8. **The vendors, who have succeeded in the tender, will have to deposit 10% of the contracted amount within one week of issuing the W.O. If security deposit is not deposited by the vendor, the 10% amount of payable value will be deducted from final payment. The Security money should be paid in form of NSE/Bank Guaranty/Bond etc in favour of Netarhat Vidyalaya Samiti, payable at Netarhat. Security deposit will be kept for 3 years.**
9. The last date for submitting the tender till 13.11.2017 on or before 05.00 p.m. The Firm/Agency should submit the tender along with required document directly at Principal's office, Netarhat Residential School or send the tender paper through speed post writing the address - Principal, Netarhat Residential School, Via – Gumla, Dist – Latehat (Jharkhand) – 835218.
