TERMS & CONDITIONS

1. The Quotation should be addressed to the "Principal", Netarhat Residential School, Netarhat, Latehar and should reach on or before 13.07.2013 up to 4 P.m. Quotation should be sent through Post/Courier/By hand. The same will be opened at the School campus on 13.07.2013 at 5 P.m.

2. Prices- The rates quoted should be inclusive of all packing, forwarding, sales tax, freight and insurance charges and should remain valid for our acceptance for a minimum period of 60 days from the due date of opening of the quotations. The quotation should be NRS consignee's site basis i.e. Netarhat Residential School, P.O- Netarhat, District- Latehar. No hike/change in prices at any stage after the submission of quotations will be allowed by the School's management.

3. The School will not entertain requests for revision in prices once quoted for whatever reason after the Quotations are opened during the period of contract.

4. Payment Terms- 100% Payment will be made within 30 days after successful delivery of the mentioned items asked in the Quotation. Triplicate copy of invoices must be submitted along with VAT and Income tax deposition certificate.

5. Delivery Period- The Supplier shall make delivery of the items within 15 days from the placement of the Purchase order. The quantity asked in the quotation is tentative; however it may marginally increase/decrease at the time of placing of order. All goods must be delivered at Stores in our School Campus at Netarhat, Distt- Latehar for inspection by our inspecting authority free of cost after confirmed order.

6. Documents required- The Firm/Vendor/Company/Dealer/Distributor has to provide following documents along with the quotation:-

a) Registration No. of the Firm/Vendor/Company/Dealership/Distributorship.

b) VAT/CST Registration Certificate.

c) Income Tax Registration Certificate.

d) Authorization from the Company(If any).

7. Brands Allowed- All the components should be of the brand/make as mentioned in the Annexure II of this document. No deviation in this regards would be entertained.
