Netarhat Residential School, Netarhat- An Autonomous body registered under Societies registration act 1860 by Ministry of HRD, Govt. of Jharkhand having its permanent campus at Netarhat, District- Latehar invites offers from the interested firms/companies/agencies, which are in the business of manufacturing, stocking (Whole selling/retailing/distributorship) or marketing of goods and services of specified categories as mentioned in the following document. Registration Form can be filled and submitted. Documents containing terms, conditions, Application format and others can be downloaded from the Institute's website www.netarhatvidyalaya.com. Hard copy of the Registration Form along with non-refundable fee must reach the office of the Principal, Netarhat Residential School by registered post/speed post/by hand only. Separate form and fee must be submitted for each category of the item. The last date for submission of application is 11th of June 2016. Application (s) received after last date of submission will not be considered.

TERMS AND CONDITIONS

1. Eligibility & Categories for Registration / Empanelment

All firms/agencies, which are in the business of manufacturing, stocking (Whole selling/retailing /distributorship) or marketing of goods and services of specified categories and service providers are eligible for registration, subject to specific conditions or restrictions stipulated in this document. Categories of items for registration are mentioned in later part of this document.

2. Empanelment/Registration Procedure

2.1. The applicant should read all the pages of the document.

2.2. Correct / relevant information / data have to be furnished by the vendors.

2.3. The applicant should make sure before applying for a particular type of Category, that it has the required eligibility criteria, is authorized dealer/distributor/agency & experience for that category of work / item.

2.4. Service providers / suppliers seeking application form shall have to pay the requisite (cost/fee) amount as stated below, for registration/empanelment. **The amount of Rs 1000/- (Rupees One Thousand only) shall be paid by a demand draft drawn in favor of The 'Principal' Netarhat Residential School ,payable at Lohardaga.**

2.5 Service providers/suppliers shall have to fill and submit the hard copy of Registration Form along with required documents and fees to The 'Principal' Netarhat Vidyalaya , Netarhat , District- Latehar, Jharkhand.

2.6. Applications incomplete in any respect, viz. non-submission of any required document or information, or fee in requisite amount are liable for rejection.

2.7. The sealed envelope containing the Registration Form, documents & fee should be clearly super-scribed on the top of the envelope as **"APPLICATION FOR VENDOR REGISTRATION / EMPANELMENT FOR THE CATEGORY CODE FOR SUPPLYING GOODS/ ITEMS/PROVIDING SERVICES AT NETARHAT RESIDENTIAL SCHOOL, NETARHAT FOR FY-2016-17"**.

2.8. Vendors / Firms registered with DGS&D and any other government body shall be considered for registration/empanelment on the basis of registration certificate of such agencies along with other certified documents.

2.9. The following self-certified essential documents (**as applicable**) should accompany the Registration Form:

(a) CST / VAT / TIN No.

(b) Trade License, Factory License.

I Income tax Permanent Account No.

(d) Memorandum and Article of Association, Certificate of Incorporation, Partnership Deed, Registration Certificate issued by the Registrar of Firms etc.

(e) Registration Certificates with DGS&D or any govt. agency.

(f) Current dealership agreement from Principal, Netarhat Residential School, Netarhat.

(g) Annual Turnover CA certified Certificate for last 3 years.

(h) Bank Details.

(i) Relevant ISO certificate.

(j) A notarized certificate that the vendor hasn't been black listed by any institution of the Central/ State government / any PSU, University, Institute etc. in the past three years.

2.10 On receipt of the Registration Form along with the requisite documents as mentioned above and after scrutiny the supplier shall be registered with the Institution.

2.11 The firm will be considered for registration / Empanelment for an initial period of one year and will be considered for renewal as per notice published next year for the same purpose.

2.12 After getting all the required fee, information & documents from the applicant, the registration number will be issued to the supplier with the following details:

- (a) Registration No.
- (b) Vendor Trade Group/ Category No. along with description.

2.13 Service Centers: Service Centre (s) in Lohardaga, Gumla, Latehar , Ranchi and Jharkhand for more than 3 years may be mentioned. For authorized distributor / OEM centers, the vendor shall produce a copy of the valid agreement / undertaking from authorized distributor / OEM. On verification of the information, if at any time the furnished information is found incorrect the registration is liable to be cancelled and the firm may be black listed by the Institute.

2.14 General Clause:

- (a) The said registration qualifies a particular vendor for consideration for issue of tender papers in case of limited tenders or advertised tender enquiry for relevant category only for which vendor is registered/empanelled. However, this will not give any claim to the party for award of work / purchase order.
- (b) The Institute reserves the rights to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of institution in respect of registration of parties for various categories of work / items shall be final & binding on all concerned registered firms / vendors in the panel of Netarhat Residential School.
- (c) Vendors once empanelled, shall have to promptly reply to all the enquiries, execute orders as per the order terms of the institution and keep the Institute informed of new products /developments / innovative ideas that shall help reduce the cost and improve quality, reliability, etc.
- (d) This document is treated as a valid contract between Netarhat Residential School and Vendor and adheres to all aspects of fair trade practices in executing the purchase orders / work orders placed by the institution from time to time if registered during the registration period.
- (e) In case of empanelled vendor is found in breach of any terms & condition(s) of the institution or supply/work order, at any stage during the course of supply / installation or warranty period, the legal action as per rules/laws, shall be initiated against the vendor and will be blacklisted for at least three years for further dealings with the institution.
- (f) The vendor should not assign or sublet the empanelment or any part or it to any other vendor in any form. Failure to do so shall result in termination of empanelment. All those firms which are registered and confirmed shall be entertained for various queries.
- (g) All registered firms are expected to maintain absolute integrity, follow a decent standard of business ethics and do nothing of becoming a foul supplier. In all future correspondence with the institution, empanelled vendors are required to quote the Registration No.
- (h) The Institute reserves all the rights reserved to add / delete / alter any of the items and to amend / add any of the terms and conditions included in the registration granted to firms with effect from any date, without assigning any reason(s) for the same.

2.15 Price Variation Clause:

During the validity of the empanelment including the extended period, if the vendor sells any empanelled item to any other department / Organization at a price lower than the price fixed for Netarhat Residential School, the vendor must voluntarily pass on the price difference to Netarhat Residential School, Netarhat with immediate effect.

2.16 Indemnity: The selected vendor shall indemnify the institute against all third party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof.

2.17 Termination for Default:

Default is said to have occurred

- i) If the vendor fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by Netarhat Residential School, Netarhat.
- ii) If the vendor fails to perform any other obligation(s) under the empanelment.
- iii) If the vendor, in either of the above circumstances, does not take remedial steps within a period of 30 days after receipt of the default notice from institute (or takes longer period in spite of what the institute may authorize in writing), may terminate the empanelment/ Purchase Order in whole or in part.

2.18 All disputes in this connection shall be settled in Jharkhand High Court, Ranchi only.
